## CHAMPIONSHIP

**EVENT:** 54 holes. Stroke Play. Starting field will consist of 288 contestants. The field will be cut to the low 60 and ties after second round play. These low 60 and ties will constitute the field for the remaining 18 holes. A tie for first place will be decided by a sudden death playoff immediately following the completion of the final round. Purse Payout is for those who return a 54 hole score.

**ENTRY FEE: \$205/Player (Amateurs), \$235/PLAYER(PGA Professional), \$385/PLAYER (Non PGA Professional).**

Payment may be made by mail with check, money order (payable to the Northern Ohio PGA) or credit card (VISA/MC Only). Credit Card (Additional Charges will Apply) entries may be faxed to 216-765-0639.

**ENTRY DEADLINE:** Entry form and fee must be received in the Northern Ohio PGA Office by **5:00 PM, Tuesday, July 15, 2008. NO EXCEPTIONS.**

### SCHEDULE:

- **Monday, July 21** First Round, 18 Holes (½ of the Field will Play Devlin Course other ½ will Play Weiskopf Course)
- **Tuesday, July 22** Second Round, 18 Holes (Weiskopf 1<sup>st</sup> Rd. Groups will Play Devlin Course & Devlin 1<sup>st</sup> Rd. Groups will Weiskopf Course)
- **Wednesday, July 23** Final Round, 18 Holes (Devlin Course)

**ELIGIBILITY:** Open to all golfers who have established and maintained a Domicile in the State of Ohio One Hundred Twenty (120) days prior to the Championship or any Northern Ohio Section Member in good standing having been employed for no less than One Hundred Twenty (120) days at a recognized golf facility prior to the Championship. Must be able to provide three (3) documents to prove Domicile. Amateurs must show proof of USGA index of 4.0 or less to be eligible.

The application for Entry which is included on the previous page is subject to acceptance and, if accepted, may be revoked at any time thereafter (including during the Championship) by the Committee or Committees in charge of the Championship, acting on behalf of The Northern Ohio Section of The Professional Golfers' Association of America and, for any reason deemed good cause by the said Committee or Committees in their discretion, without liability to the said Committee or Committees, Association or Corporation of the Sponsors of the Championship. The reason for rejection may include unbecoming conduct.

It is understood that the said Application and its acceptance are further subject to compliance by the Applicant with all provisions of the Constitution, By-Laws, Rules and Regulations of the Professional Golfers' Association of America and The Northern Ohio Section with respect to the said Championship, with all the terms and conditions of the Contract for the said Championship which has been entered into

between The Northern Ohio Section PGA and the Sponsor thereof, with any and all Rules and/or Regulations concerning the said Championship which are or may be established by the Committee or Committees in charge of same and to all information disclosed by the records of the said Association with respect to Applicant's eligibility to participate in the said Championship. In consideration of the acceptance of the said Application, the Applicant consents to the recording and transmission of his voice and to being publicized, filmed, photographed, or televised in connection with his participation in the said Championship, and waives, releases and assigns to the Northern Ohio Section of The Professional Golfers' Association of America and/or its assigns any and all of his private rights to the production, reproduction, publication and dissemination of any publicity, recordings, transmissions, motion pictures, photographs or images which depict him as a participant in the said Championship or any phase or portion thereof. By execution of this application form, each applicant acknowledges that he is not entitled to remuneration of any kind for participation in the competition other than the prizes set forth.

**RULES OF PLAY:** USGA Rules of Golf will govern play with the exception of such Local Rules as are established by the Rules Committee. The Rules Committee's decision will be final. Copies of the rules will be available to all contestants.

**NON-METAL SPIKE POLICY:** As a condition of this competition, it is required that all professional and amateur participants wear non-metal spikes. Metal spikes of any kind, including the nonmetal spikes with a metal insert, will not be allowed. This policy is in effect during all championship rounds. In consideration of participation, participant hereby releases Section and holds Section harmless from any and all claims for loss or damage whether or not caused by participant's use of non-metal spike golf shoes. **Penalty for non-conformance is Disqualification.**

**PRACTICE:** A Practice round fee will be charged to each participant choosing to play a practice round. Practice rounds will ONLY be granted to those who have an approved entry on file. Please call the Host PGA Professionals for starting times. Quail Hollow CC (440-639-4000)

**CADDIES AND AUTOMOTIVE GOLF CARS:** All contestants MUST use a caddie, use an automotive golf car or carry their clubs During the Championship rounds.

**STARTING TIMES:** Pairings and starting times will be posted after 5:00 PM July 17, 2008 on the Website of the Northern Ohio PGA at [www.northernohio.pga.com](http://www.northernohio.pga.com). Also, pairings and starting times will be posted at Quail Hollow Country Club. Any participant who fails to report to the starter at his assigned time will be subject to penalty or disqualification.

**DRESS CODE:** Proper dress code is required. Jeans, of any style, cut-offs and tank tops are not permitted.
